## **Frisco Fighters Bombshells Waiver and Release**

The undersigned requests that she be allowed to demonstrate her skill and ability as a contestant during the auditions for the Frisco Fighters Bombshells. In considerations of being afforded such opportunity, the undersigned hereby assumes the risk of injury inherent in such activity and waives any claim for damages of any kind, including serious injury, against the Frisco Fighters Bombshells, Frisco Fighters, Pure Movement Dance, the Indoor Football League and personnel for any injuries that may be sustained by the undersigned during such demonstration.

In recognition of the media coverage of the Frisco Fighters Bombshells and applicants thereto, the undersigned grants the Frisco Fighters, Pure Movement Dance, the Indoor Football League and its licensees her permission and authority to use her name, voice, picture, and likeness in connection with any and all publications, media, broadcasts, promotional photographs, promotional posters, commercial products, including but not limited to calendars, team pictures, T-shirts, and any other commercial items with no further compensation to applicant.

In further consideration of the Frisco Fighters allowing the undersigned to audition for the Frisco Fighters Bombshells, and in the event the undersigned is offered employment to become a member of the Frisco Fighters Bombshells, she hereby understands and agrees that as a condition of employment, she must sign the standard Frisco Fighters Bombshells agreement and provide written authorization under the Fair Credit Reporting Act for the Frisco Fighters to conduct a background check.
